I will not sell as registed (on the full register) any dog or bitch which has defects of a nature that is detrimental to the breed. I will supply each purchaser with the following where applicable, at the time of sale. (a) Registration Certificate (b) A three or four generation Pedigree Certificate

All advertising will be honest and not in anyway misrepresentative, misleading or fraudulent. I will continue to offer helpful assistance to the buyer as long as such aid is required. I will not sell or donate any Cocker Spaniel to Commercial Dog Wholesalers, retail pet dealer, or directly or indirectly allow them to be given as prizes in contests of any kind, or for any purpose that may lead to their exploitation.
